These provisionally selected pilgrims may be advised that after depositing the amount, they shall submit Pay-in-Slip, Haj Application Form (HAF), Solemn Declaration and Medical Screening & Fitness Certificate (Government Medical Officer/Doctor) along with Original International Passport to the concerned State Haj Committee on or before 14.05.2024.
